WHAT DOES PATRIA LENDING, LLC DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> ■ Social Security and checking account information ■ Payment history and income ■ Employment data and bank debit card or account information
How?	All financial companies need to share customers' information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Patria Lending, LLC chooses to share; and whether you can limit this sharing.

Who is providing this notice?

This privacy notice is provided by Patria Lending, LLC.

What we do

How does Patria Lending protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Patria Lending collect my personal information?

We collect your personal information, for example, when you

- submit a loan application or share contact or account information
- provide financial information or employment information
- arrange payments or update information on your account

We also collect your personal information from credit reporting agencies, financial companies, service providers and other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more information.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choice will apply to everyone on your account.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliates include entities wholly owned by the Otoe-Missouria Tribe of Indians, a federally recognized Indian Tribe.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Nonaffiliates with which we share personal information include service providers and direct marketing companies for application marketing, direct mail and other purposes.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Our joint marketing partners can include companies with which we have agreements to jointly market products.
